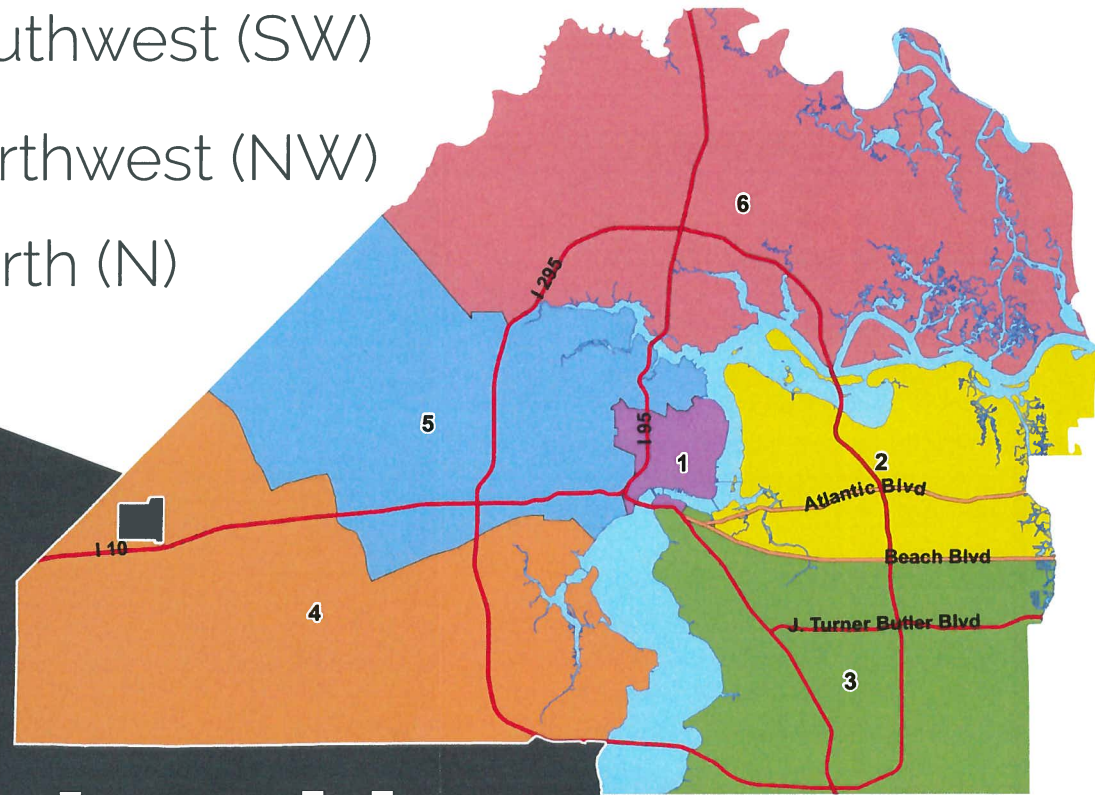

# Citizens Matter

Jacksonville's more than 200 neighborhoods are divided into six planning districts, each with a Citizen Planning Advisory Council (CPAC). The primary purpose of a CPAC is to maintain open and effective communication between stakeholders including Jacksonville residents, businesses, neighborhoods, community organizations, educational institutions and city government. Effective government requires meaningful citizen participation. Therefore, broad-based public involvement in planning, land use, zoning, transportation, community services, economic development, recreation, schools, police and public safety are absolutely essential. CPACs help identify local concerns and offer solutions. They also afford citizens the opportunity to make recommendations on major city plans, projects and programs. Citizens of any neighborhood within a planning district are encouraged to attend meetings to learn more about issues impacting their communities.
